The Cooperative shall give advance notice of that deadline in the Cooperative's newsletter or through some other means. 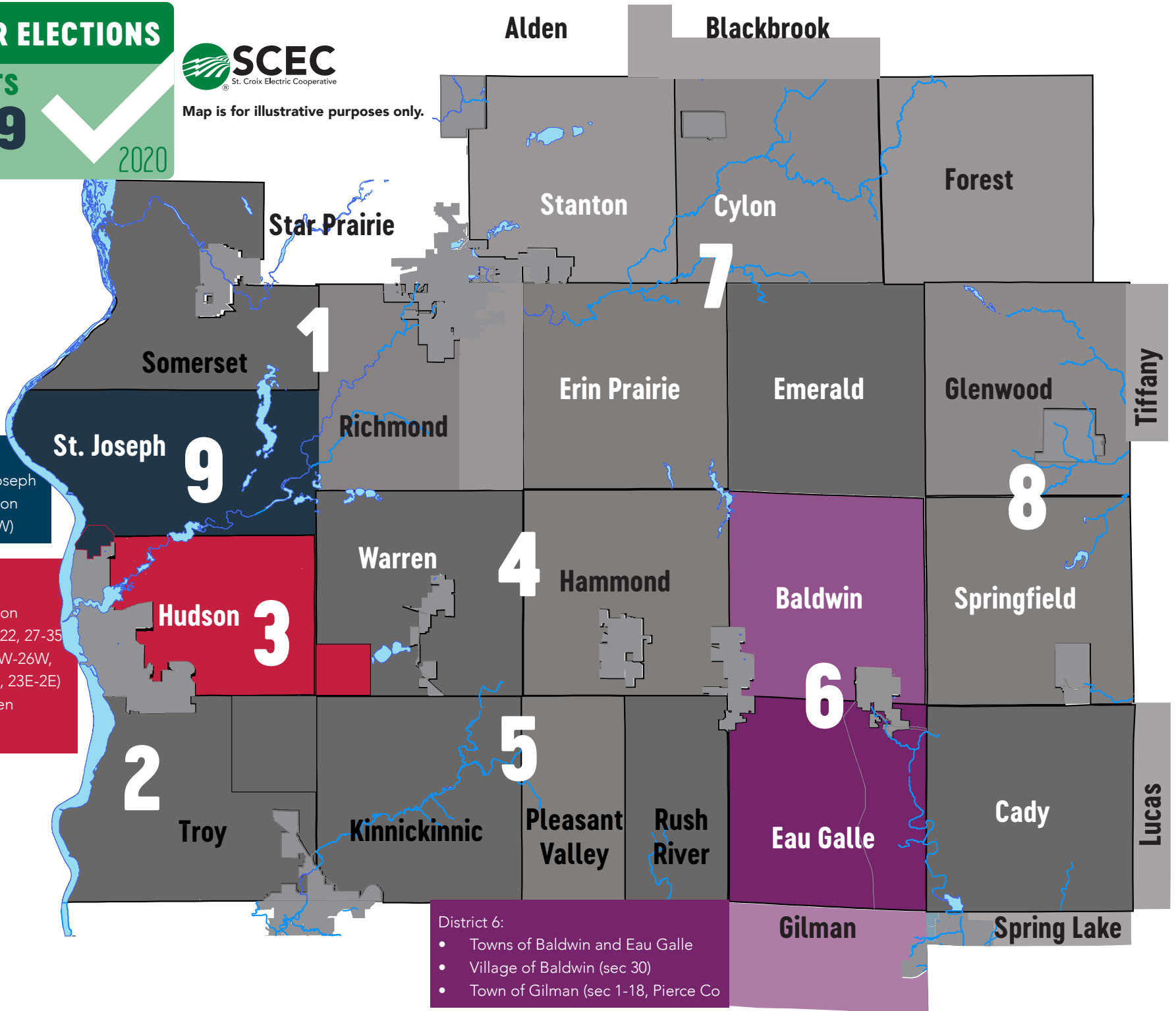
